AD4L Treasurers Report 4th FEB 2024 (all currencies are in AUD):

AD4L has received \$1,478.18AUD (net of withdrawal fee) in PayPal contributions, alongside with \$80AUD directly into the bank account over the past two months, since the last treasury report on December 3rd, 2023. On behalf of our fellowship, our sincere gratitude to everyone who continues to support AD4L.

Since the December balance was below \$1k, there was no donation made in the period. We therefore currently have \$2,345.81AUD which is available for donation.

AD4L also maintains two reserves amounts: Annual World Service Business Conference (3500AUD); and the ZOOM administration (850AUD).

AD4L has submitted its annual report to the Australian Charities and Not-for-profits Commission in January 2024, required to confirm and maintain our Not-For-Profit status.
