AD4L Treasurers Report 1<sup>th</sup> JUNE 2024 (all Currencies are in AUD):

AD4L has received **\$560.69AUD** (net of Paypal Withdrawal Fee) in contributions over the past month. On behalf of our Fellowship, our sincerest gratitude to everyone who continues to support AD4L.

The OA.ORG website has implemented a new portal for making donations. This created some difficulty for us. We were not able to put through the intended donation amount of **\$1247.33AUD**. We are awaiting further instructions on how to use the new payment portal.

AD4L has **\$560.74AUD** available for donation. It is our policy to wait until there is over \$1000 before making a new donation. (The \$560.74 is the difference between the \$1808.07 (below) and the yet to be donated amount \$1247.33).

We have begun working on the annual government financial report for A Design For Living Intergroup. This is due DEC 2024.

NOTE: AD4L maintains 2 reserve amounts: Annual World Service Business Conference (\$3500AUD); and the annual ZOOM Administration Reserve (\$850AUD).
