This is the treasurer’s report for AD4L’s April Group Conscience. AD4L received **\$ 180.19 AUD** (net of PayPal Withdrawal Fee) in contributions. On behalf of our Fellowship, our sincerest gratitude to everyone who continues to support AD4L.

This month the outstanding donations from February and March were successfully processed. Due to currency and exchange rates the amount donated was slightly less that expected at **\$2114.31 AUD**. We also paid a website hosting fee of **\$73.57 AUD**.
